**MINIMUM CALLS** BMCC Tribeca Performing Arts Center staff have a minimum call of 4 (four) hours.

**OVERTIME RATES** Billed at one and one half times regular hourly rates and apply for any hours in **excess of 10 (ten) hours per day**; any hour worked between 6:00 am - 8:00 am or after 12:00 am; any hours in excess of 40 (forty) hours worked in one week. The week is Monday through Sunday.
